1085 MILITARY ROAD – AUTO IMAGE COLLISION SIGN

Business owner Judah Gehl reviewed his sign proposal. His request is for both an automated sign and a flat white sign, located on a pole. There would be no strobe or flashing on the automated sign. Mr. Gehl would like an approval for a white background. The steel tube will be sheeted with white aluminum.

Bruce Shearer stated that plantings are required at the base of the pole.

Frederick Frank suggested flower pots so they can be removed for plowing.

Mr. Gehl would like an LED sign with amber letters and a red background.

Building Inspector Michael Berns explained to Mr. Gehl that Village law requires that the lettering can only be one color on a black-only background.

Bruce Shearer moved to approve a white background with blue letters; the LED sign must have a black background and single color letters; the 5” square pole will be sheeted with white aluminum and cabinet internally lit. Plantings will be placed at the base of the poll.

Seconded by Thomas Fleming and adopted by a full vote of all members present.

2931 DELAWARE AVENUE – NATURAL EYEBROWS THREADING

This business will provide facial hair removal.

Clerk Treasurer Kathleen Johnson explains that, while tattoo parlors are not allowed, henna would not fall into this category because of the method of application and because henna is not permanent. The applicant noted that henna is only applied to hands for parties and weddings.

Noreen Flynn moved to approve as presented, with white lettering.

Seconded by Bruce Shearer and adopted by a full vote of all members present.

3070 DELAWARE AVENUE – FUNERAL HOME

The applicant is proposing a monument sign which would be internally lit. The sign is five feet wide with an aluminum face and plastic letters.

Frederick Frank stated that the bracket for a sign needs to come down if no sign will be used. If a sign is to be used it needs to be approved.

Mr. Frank approved as presented, conditioned that the brackets be removed.

Seconded by Bruce Shearer and adopted by a full vote of all members present.

2630 ELMWOOD AVENUE – VAPOR CHAMBER

It is noted that the sign is already up.

Building Inspector Michael Berns feels that the application is incomplete

Mr. Shearer approved the signage, as notated on the rendering signed by Clerk/Treasurer Kathleen Johnson.

Seconded by Thomas Fleming and adopted by a full vote of all members present.

2701 ELMWOOD AVENUE – THE REAL BARBERS

Bruce Shearer moved to approved as presented.

Seconded by Marcia Brogan and adopted by a full vote of all members present.
