INVITATION FOR PUBLIC COMMENT/QUESTIONS

The Mayor asked if anyone wished to be heard.

Mike Murphy of 42 LaSalle Avenue stated he has a concern about the water rates going up. Mr. Murphy stated he spoke with Clerk/Treasurer Kathleen P. Johnson about the DEC surcharge and he understands why that was implemented. His concern is the actual rates and surcharges. The Mayor explained that a public hearing was held, and a legal notice issued, prior to approving the rates. He reiterated that the new surcharge is to address the DEC Consent Order requirements for remediation of our 100 years old infrastructure. The other rate increases were needed to address our cost increases for the purchase of water and our costs to clean sanitary sewer water. Both services are provided through the Town of Tonawanda. Mr. Murphy has no complaints about the Department of Public Works. He lived in Buffalo previously and says the Village services are much better than Buffalo's.

As no one else wished to be heard the meeting was adjourned.
