INVITATION FOR PUBLIC COMMENT/QUESTIONS

The Mayor asked if anyone wished to be heard.

Sue Muscarella of 62 Westgate Road was representing her neighbors to complain about the remediation of their properties following the 2016 Water Main replacement project. She states that every lawn has a divot which makes mowing difficult and presents and unsafe condition. Mayor Patrick Mang requested that Department of Public Works Superintendent David Root inspect the street and notify the contractor so that the lawns are restored.

Mary Ellen Voigt 61 Westgate stated that she had contacted the DPW several times about the situation and that she and her neighbors should not have to pay for sod to correct the problem. She states that trucks left ruts in the lawns. The Westgate neighbors take good care of their properties and she feels that they have been patient – allowing time for settling and then for the matter to be addressed, but at this point they want the condition corrected.

Mayor Patrick Mang thanked the Westgate residents for coming to the meeting. As no one else wished to be heard, the meeting was adjourned.
