BOARD CONDUCTED A HEARING PERTAINING TO THE DISCONTINUATION OF WATER SERVICE AT 736 COLVIN BOULEVARD.

The Clerk advised that this was the time and place to conduct a hearing pertaining to the discontinuation of water service at 736 Colvin Boulevard.

Trustee Bestine moved to open the hearing.

Seconded by Trustee DeCecco and adopted by a full vote in the affirmative.

The Mayor asked if anyone was present representing 736 Colvin Boulevard. No one was present. The Mayor then asked if there were any questions or comments. There were none.

ABSTRACT OF AUDITED VOUCHERS.

Trustee Burd offered the following resolution and moved for its adoption: **RESOLVED,** that the Mayor be and he hereby is authorized to sign the Abstract of Audited Vouchers dated July 16, 2019 in the amount of \$930,498.72; General Fund \$269,184.52; Water Fund \$174,854.37; Sewer Fund \$327,343.97; Capital Fund \$158,273.98; Community Development Fund \$841.88: to direct the Treasurer to pay each of the listed claimants in the amount appearing opposite his/her name.

Seconded by Trustee Catalano and adopted by a full vote of all members present.

INVITATION FOR PUBLIC COMMENT/QUESTIONS

The Mayor asked if anyone wished to be heard.

Victoria Christopher of 311 West Hazeltine Avenue expressed concerns about 301 West Hazeltine Avenue. Building Inspector Michael Berns stated that there have been 9-10 outstanding violations since 2018 on the property. He believes all utilities on at the property have been shut off. Mr. Berns noted that there is an abandoned car on the property, which will be

reviewed at a hearing at the next Board meeting, if it is not properly stored. He stated that the property may be in foreclosure. Ms. Christopher stated that some of the windows are broken and she asks if they can be boarded. Mr. Berns stated that that would be reviewed and considered through a separate hearing.

Noreen Smith of 303 West Hazeltine Avenue reiterated Ms. Christopher's concerns.

Mayor Mang explained that the Village has limited options and that the process takes time. He asked the neighbors in attendance to contact the Police Department if they see anyone at the property, because one of the biggest difficulties for the Village is finding the correct person to address violations. Ms. Smith stated that someone comes around 3 to pick up the mail.

Patty Cattone, 316 West Hazeltine Avenue, stated that the house has been a problem for many years and continues to deteriorate. Something needs to be done.

She then told the Board about a problem she is having with the Family Dollar Store on Kenmore Avenue on the Buffalo side. A light is buzzing so loudly at night that she can't sleep. She's complained to the Buffalo Building Department and the Buffalo Police Department but to no avail. She is wondering if the Village can help. The Mayor said the Building Department can reach out to Buffalo to see if they can address it.

Candace Burley, 312 West Hazeltine complained about the trash in the back of the Kenmore Lanes and at 308 West Hazeltine Avenue.

Mayor Mang will have Building Inspector Michael Berns look into it.

Mr. Berns stated that he has already sent violations out, but will re-inspect.

Sue Schafer of 801 Colvin Blvd complained about the dead trees on Colvin. She only recently learned that, because Colvin is a County road, these trees are owned and maintained by

the County. She said that the County took down one of her two dead trees, but that workers told

her they would not be coming back to stump or to take down her other dead tree. Trustee

Bestine stated she also has a dead tree in front of her home that the County hasn't addressed. Ms.

Schafer stated she's tempted to take down the tree with her chain saw.

Superintendent of Public Works David Root stated he has gone around and around with

Erie County on this issue.

Constance Nowak of 338 West Hazeltine Avenue complained about Price Rite with

respect to tall grass behind the building and garbage.

Mayor Mang referred it to Building Inspector Michael Burns.

As no one else wished to be heard, the meeting was adjourned.
