The meeting was called to order at 7:30 p.m. by Mayor Mang. The Mayor led the Pledge of Allegiance.

BOARD APPROVED AND GAVE PERMISSION FOR TWO POLICE DETECTIVES TO ATTEND A TRAINING COURSE.

Trustee Catalano moved to approve and give permission for Detective Michael Wells and Detective Justin Breitnauer to attend the "Mid-Level Narcotics Investigation Training" on March 9-10, 2023 at Hilbert College in Hamburg, N.Y., with expenses.

Seconded by Trustee Czopp and adopted by a full vote in the affirmative.

BOARD APPROVED AND GAVE PERMISSION TO THE DEPARTMENT OF PUBLIC WORKS SUPERINTENDENT TO ATTEND "ADVOCACY DAY".

Seconded by Trustee Czopp and adopted by a full vote of all members present.

ABSTRACT OF AUDITED VOUCHERS.

Trustee Czopp offered the following resolution and moved for its adoption: **RESOLVED,** that the mayor be and he hereby is authorized to sign the Abstract of Audited vouchers dated February 21, 2023, in the amount of \$510,293.56; General Fund \$186,930.22; Water Fund \$47,081.29; Sewer Fund \$68,386.05.00; Capital Fund \$207,896.00; to direct the Treasurer to pay each of the listed claimants in the amount appearing opposite his/her name.

Seconded by Trustee Catalano and adopted by a full vote in the affirmative.

INVITATION FOR PUBLIC COMMENT/QUESTIONS

The Mayor asked if anyone wished to be heard.

Sam Guarino of 221 Keller Avenue wanted to discuss the new owner account fee for his property. He states that this property has been in his family for many years and that his mother only recently paid the new owner fee. This property is a double, so there is a new owner fee attached to both units. He feels it's unfair that he has to pay this fee again, when it was just paid. His mother recently transferred the property to him and he wants this fee waived.

Clerk/Treasurer Johnson noted that she had previously talked with Mr. Guarino about this matter. Under the Village Code, there is no exception for intra-family transfers. All new owners

have to have the new owner fee attached. She noted that when the new owner fee goes on the

bill, no surcharges are added to the bill. The difference between the new owner fee and the

surcharges is approximately \$30. She further noted that, while she couldn't recall the exact date,

his mother had taken title some time ago, but failed to place the account into her name until only

recently. The New Owner fee for his mother was her responsibility, not Mr. Guarino's, and the

delay in placing the account into her name is resulting in 2 successive new owner fees. She also

noted that, while the Code exempts intra-family transfers for \$1 and no more from Sump Pump

Inspection and certificates, as well as Tax Certificate acquisition, there is no such exemption for

New Owner fees.

The Mayor noted that he is aware that this is a family transfer, but that the law doesn't

give exemption to the new owner fee. That said, the Mayor stated that he and the Board would

look into it.

As no one else wished to be heard, the meeting was adjourned.
