### **INVITATION FOR PUBLIC COMMENT/QUESTIONS**

Sam Guarino of 221 Keller Avenue asked if a decision was made regarding his request to waive the new owner fee from his water account.

Mayor Mang responded that the law would need to be changed. The Board didn't feel that a change was needed and that no waiver would be given.

Mr. Guarino asked why the new account fee was so high. Clerk/Treasurer Kathleen Johnson noted that she had previously talked with Mr. Guarino and had explained that, for the billing in which the new owner fee is applied, there are no surcharges. As a result, the resident is only paying \$35 more than would have been paid if the surcharges were included. Basically, the new owner fee includes the surcharges.

Mr. Guarino said that he believes that Kenmore water rates are higher than other municipalities and asked why. The Mayor responded that he will look into this and get back to Mr. Guarino.
