The meeting was called to order at 8:00 p.m. by Mayor Patrick Mang. The Mayor led the Pledge of Allegiance.

**BOARD APPROVED THE APPOINTMENT OF A PART-TIME DISPATCHER FOR THE KENMORE POLICE DEPARTMENT.**

Trustee DeCecco moved to approve the appointment of James Zsiros as a part-time Dispatcher for the Kenmore Police Department, at a starting salary of \$15.42, effective July 24, 2018.

**BOARD APPROVED THE APPOINTMENT OF A PART-TIME VAN DRIVER FOR THE SENIOR NUTRITION PROGRAM.**

**BOARD APPROVED A STREET CLOSURE ON SOMERTON AVENUE FOR THE CORVETTE CARAVAN.**

Trustee DeCecco moved to approve and granted permission to the Corvettes of Buffalo for a street closure on Somerton Avenue, between Delaware Avenue and Grammercy Place, on September 15, 2018 for the Corvette Meet and Greet at the request of Robert Joseph.

**ABSTRACT OF AUDITED VOUCHERS.**

Trustee Burd offered the following resolution and moved for its adoption: **RESOLVED**, that the Mayor be and he hereby is authorized to sign the Abstract of Audited Vouchers dated August 7, 2018, in the amount of \$320,075.35; General Fund \$289,629.73; Water Fund \$7,839.00; Sewer Fund \$1,617.16; Capital Fund \$13,617.16 to direct the Treasurer to pay each of the listed claimants in the amount appearing opposite his/her name.

**INVITATION FOR PUBLIC COMMENT/QUESTIONS**

The Mayor asked if anyone wished to be heard.

George Schwarztrauber of 303 Stillwell Avenue stated that the condition at 305 Stillwell Avenue looks like a junk yard and that he believes the next-door neighbor is running a salvage business in the yard. There's a lot of noise from sledge hammers. He also states there are rodents. He says that the view from his property is horrible and that the property condition at 305 Stillwell has had a negative impact on his property value and quality of life and enjoyment.

He also stated that he has applied for a hearing before the Zoning Board of Appeal in hopes of getting a variance for an 8 foot fence. He understands that there has been some delay caused by the need to fill vacancies to the ZBA. Kenmore Police Department has been called pertaining to the noise, but he has been told that noise level is not specific in the code. Suggests the Board look into adding these issues into the code and welcomes village officials to enter his property. He states that the condition has been going on for years and is getting worse. He hasn't talked to the neighbor in 4-5 years. Mr. Schwarztrauber stated he can hear the noise plainly from inside his home.

Mayor Mang responded that he is aware of the problem and will look into this to see what the Village can do. He also confirmed that the Village Board filled the ZBA vacancies just recently, so the hearing should be set soon.

As no one else wished to be heard, the meeting was adjourned.
