#### **ABSTRACT OF AUDITED VOUCHERS.**

Trustee Catalano offered the following resolution and moved for its adoption:

**RESOLVED**, that the mayor be and he hereby is authorized to sign the Abstract of Audited

vouchers dated June 18, 2024, in the amount of \$1,086,171.32; General Fund \$212,521.93:

Water Fund \$83,767.03; Sewer Fund \$103,863.05; Community Development Fund \$46,488.53;

Capital Fund \$639,530.78; to direct the Treasurer to pay each of the listed claimants in the

amount appearing opposite his/her name.

Seconded by Trustee DeCecco and adopted by a full vote in the affirmative.

#### **INVITATION FOR PUBLIC COMMENT/QUESTIONS**

The Mayor asked if anyone wished to be heard.

Tim Glascow, residing 226 East Hazeltine Avenue, asked if the Board would consider installing speed bumps on East Hazeltine.

The Mayor replied that he and the Board has had this discussion in the past. He said that the Kenmore Police Department has done studies and found that they seldom see vehicles travelling in excess of 30 mph. The Mayor also noted that speed bumps present a problem for emergency vehicles and cause additional wear and tear on all equipment. He also noted that if speed bumps were to be placed on Hazeltine, traffic would shift to another street, increasing traffic to that street.

Mr. Glascow thanked the Mayor for his response and the Mayor thanked Mr. Glascow for taking the time to attend the meeting.

Scott Glascow, also residing on East Hazeltine, asked if the Board had considered lowering the speed limit to 20 mph.

The Mayor stated that they had discussed this, but that there was no interest in doing so,

Trustee Catalano suggested that the Kenmore Police place the speed recorder on East Hazeltine again to see if there is a speeding issue.

Kelly Boos of 168 Knowlton, stated that her neighbor at 165 Wardman Rd. has built a tree house, which has a window that overlooks her yard. She stated that the window is higher than the 6-foot privacy fence. She feels that this interferes with her privacy. She is interested in getting a variance that would allow her to construct a 9-foot fence.

Trustee DeCecco noted that variances last forever and likely she would not meet the standard for approval. He asks Ms. Boos if there is another option that would satisfy her need for privacy.

Ms. Boos asked if she could put up a planter or a ten-foot trellis.

Building Inspector Michael Berns stated that, if the trellis were attached to the fence, it would not be allowed. If the trellis is free standing and not attached to the fence, it would be allowed.

Mayor Mang suggested that Ms. Boos consult with the Building Inspector before selecting an option, just to make sure that what she is considering is allowed.

Trustee DeCecco suggested that she talk to her neighbor (with whom Ms. Boos says she has a good relationship) and ask him to cover the window with shutters, or opaque glass. Ms. Boos said that the window is actually an entry into the tree house.
