#### **INVITATION FOR PUBLIC COMMENT/QUESTIONS**

The Mayor asked if anyone wished to be heard.

Jeff Fildes, Shepard Avenue, wished to voice concerns for outdoor events at Fattey Beer and the negative impact that these events are having on the residents.

He said that he had talked with Clerk/Treasurer Kathleen P. Johnson several times and has also talked with State Liquor Authority (SLA). Mr. Fildes stated that the proposed Local Law would allow 10 events/year and that, since these would most likely take place during the summer months, that would mean a disruption to the neighborhood 3 times a month. He said that, in addition to the sound issue, patrons take all the street parking, making it difficult for the residents if they need to leave during the event or want to have their own gatherings.

He is concerned on the size of the tent, which he feels shows that Fattey's is anticipating a very large gathering.

Mayor Mang replied that the law is still being reviewed. He asked Mr. Fildes how things went on Memorial Day. He said that the Memorial Day event was a litmus test to see how things went.

Mr. Fildes replied that it was not as loud as previous events, and that the event ended on time. He sees this as an improvement, but notes that there are still issues with public urination and open bottles on the street as people leave. He doesn't feel there are enough outdoor bathrooms to accommodate the crowds.

He said that he has contacted the SLA and was told that Fattey's can only use the outdoor patio space for service of alcohol. He believes Fattey's is extending the patio out into the parking lot and is in violation of SLA approval.

He feels that Fattey's isn't following the rules and needs to be held accountable.

He also believes that they are required to sell food items outside, which is not happening.

Mayor Mang repeated that the Village Board has not approved the law, nor has it given any authorization to Fattey's for additional events. He said that he will be meeting Fattey's representatives on Thursday. He also noted that the proposed local law would require applicants to show their SLA application, so that the Village knows where they are allowed to have alcohol.

Mayor Mang acknowledged that last year, things got out of hand, which is why the Village has been working on a local law to address outdoor events held on private property.

Trustee Ring stated that last year there were no restrictions and that the new law, once passed, will provide guidance to everyone as to what is expected.

Trustee Catalano noted that the Board had requested that Fattey's position the tent so that it was facing Delaware and requested that the side walls be in place to help with the sound issue. The Board is also looking to end these events earlier for the benefit of the surrounding neighborhood.

Mr. Fildes stated that Fattie's failed to distribute a note to the residents, informing of them of the event date and time.

There were no other questions or comments.

The meeting was adjourned.
