- 25% or more of the total number of labor hours worked on the project are performed by Section 3 Workers.
- 5% or more of the total number of labor hours worked on the project are performed by Targeted Section 3 Workers (as part of/within the 25% outlined above)
 - If the above goals are not met, the Village and contractor have to provide proof of qualitative efforts to try to reach those goals the winning contractors will have to complete their own Section 3 Participation Plan for approval by HCR which will include this effort.
